THE PROPOSED SALE AND PURCHASE OF SECTIONAL TITLE REAL RIGHTS OF EXTENSION ON AN IMMOVABLE PROPERTY BEING LOT 54349 GABORONE BY CBD FIELDS HOLDINGS (PTY) LTD FROM SMART PARTNERSHIP ENTERPRISES (PTY) LTD

Pursuant to section 49(1) of the Competition Act of 2018, the Competition and Consumer Authority ("the Authority") has received a merger notification for the proposed sale and purchase of sectional title real rights of extension on an immovable property being lot 54349 Gaborone by CBD Fields Holdings (Pty) Ltd ("CBD Fields") from Smart Partnership Enterprises (Pty) Ltd ("Smart Partnership").

The Acquirer, CBD Fields, is a company incorporated in accordance with the Laws of Botswana. CBD Fields is directly controlled by Smart Partnership Enterprises (Pty) Ltd. CBD Fields does not directly or indirectly control any firm in Botswana. It suffices to note that CBD Fields has not commenced trading operations and does not provide any service or sell any products into or from Botswana.

The Target Enterprise, Smart Partnership, is a private company incorporated in accordance with the Laws of the Republic of Botswana. Smart Partnership is not directly or indirectly controlled by any firm. However, it does directly control CBD Fields Holdings (Pty) Ltd. Smart Partnership is in the property portfolio industry. It is currently the registered owner of immovable property being a piece of land on Lot 54349 Gaborone. Smart Partnership does not provide any service or sell any products into or from Botswana.
